CIRCULAR

Subject: Implementation of Coastal Zone Management Plans (CZMP) of Mumbai City, Mumbai Suburban, Thane, Palghar, Raigad, Ratnagiri & Sindhudurg Districts under provisions of the CRZ Notification, 2019

You are aware that, the Ministry of Environment, Forest & Climate Change (MoEF&CC), New Delhi, vide G.S.R. 37(E) dated 18.01.2019 has published the CRZ Notification, 2019 in supersession of earlier CRZ Notification, 2011. As per the provisions of CRZ Notification, 2019, Coastal Zone Management Plans (CZMPs) of Mumbai City, Mumbai Suburban, Thane, Palghar, Raigad, Ratnagiri & Sindhudurg Districts are prepared by the National Center of Sustainable Coastal management, Chennai which is authorized agency of the MoEF&CC, New Delhi.


2. Accordingly, the Ministry of Environment, Forest & Climate Change (MoEF&CC), New Delhi vide letter dated 29.09.2021 and 25.08.2023 has approved the CZMPs of Mumbai City, Mumbai Suburban and Thane, Palghar, Raigad, Ratnagiri & Sindhudurg Districts respectively, under provisions of the CRZ Notification, 2019. The said approved CZMPs are published and available on website of the MCZMA i.e. <https://mczma.gov.in/>

3. The Concern Planning Authorities / District Collector / Local bodies shall follow the said approved CZMPs and provisions of CRZ Notification, 2019 in their jurisdiction. As per provisions of the CRZ Notification, 2019, prior CRZ recommendation from the MCZMA is required for the project activities attracting CRZ Notification, 2019.

4. The MoEF&CC, New Delhi issued Office Memorandum dated 29.11.2022 prescribing the procedure for clearance of permissible activities as per CRZ Notification, 2019. The MoEF&CC also directed Coastal States to process all CRZ clearance proposals online on PARIVESH 2.0 Portal Only. Therefore, Project Proponent shall apply on PARIVESH 2.0 Portal <https://parivesh.nic.in/> with all mandatory documents for seeking prior CRZ Clearance for areas falling in Coastal Regulation Zone as per approved CZMPs under CRZ Notification, 2019.

5. Activities proposed beyond CRZ areas as per approved CZMP, 2019 are outside the ambit of CRZ Notification, 2019.
