Subject: Coastal Zone Management Plans (CZMP) under provisions of the CRZ Notification, 2011 with respect to 5 Coastal districts namely, Mumbai City, Mumbai Suburban, Raigad, Ratnagiri & Sindhudurg Districts.

You are aware that, preparation and approval of the Coastal Zone Management Plans (CZMPs) under provisions of the CRZ Notification, 2011 were in progress. This is to hereby inform that, the Ministry of Environment, Forest & Climate Change (MoEF&CC), New Delhi vide letter dated 16th August, 2018 approved the CZMPs of Mumbai City, Mumbai Suburban, Raigad, Ratnagiri and Sindhudurg districts, under provisions of the CRZ Notification, 2011. Accordingly, the said approved CZMPs have been published and uploaded on website of the Maharashtra Coastal Zone Management Authority (MCZMA).

2. The MCZMA in its 127th meeting held on 02nd November, 2018 noted and took on record the said approval issued by the MoEF&CC, New Delhi with respect to above mentioned 5 coastal districts. The MCZMA in the said meeting decided that the Concern Planning Authorities / District Collector shall follow the said approved CZMPs in their jurisdiction. As per provisions of the CRZ Notification, 2011, prior CRZ recommendation from the MCZMA is required for the activities regulated and permissible in CRZ area and application should be as per newly approved CZMP under CRZ Notification, 2011. The MCZMA has also developed portal for online applications.

3. Copies of the above said approval letter dated 16th August, 2018 issued by the MoEF&CC, New Delhi and minutes of 127th meeting of the MCZMA are attached herewith. Copies of the said approved CZMPs are available of MCZMA's website i.e. <https://mczma.gov.in/>
