
**Subject:** PARIVESH 2.0 portal for online proposal submission for the projects attracting provisions of Coastal Regulation Zone Notification 2011 & 2019

The Ministry of Environment, Forests & Climate Change (MoEF & CC), Government of India, New Delhi has issued the Coastal Regulation Zone Notification, 2011 & 2019.

2. Taking further steps towards more efficacy and transparency in the functioning, the MCZMA has developed website i.e. <http://mczma.gov.in> which hosting Coastal Zone Management Plans (CZMPs), Acts, Notifications, Office Memorandums, Circulars as well as MCZMA meeting agenda, minutes, decisions of MCZMA, complaints, RTI, other relevant reports / news / initiatives of MCZMA.

In order to bring more transparency and accountability the Ministry of Environment, Forests and Climate change, Government of India has launched a portal named as "Pro Active Responsive facilitation by Interactive and Virtuous Environmental Singlewindow Hub" (PARIVESH 2.0) for online submission and monitoring of the proposals submitted by the user agencies for seeking CRZ clearances.

Therefore, all applicants are hereby requested to submit applications only through PARIVESH 2.0 portal on <https://parivesh.nic.in> w.e.f. 15<sup>th</sup> July 2023 for proposals attracting CRZ Notification, 2011 & 2019. Along with submission of proposal, the scrutiny fees of MCZMA should be submitted online through E-payment on <http://mczma.gov.in>. Further, no offline proposal will be considered from 15<sup>th</sup> July 2023.
